The Independent Anti-Slavery Commissioner, Mr Hyland, is keen to establish, what if any mandatory training that law enforcement agencies receive on Modern Day Slavery and Trafficking. Is there an Ncalt package that all officers have to view and pass?

Is there separate training given to investigating officers and senior investigating officers.

Have any forces adopted training within this field that has been accredited by the College of Policing, or is this done on an ad hoc basis from force to force. If this is the case are you aware of courses that have received a good reaction.

If there is no mandatory training has any been considered and/or being prepared.

Obviously Mr Hyland is keen to promote this area of policing and feels that awareness needs to be improved, throughout all ranks within law enforcement.
