

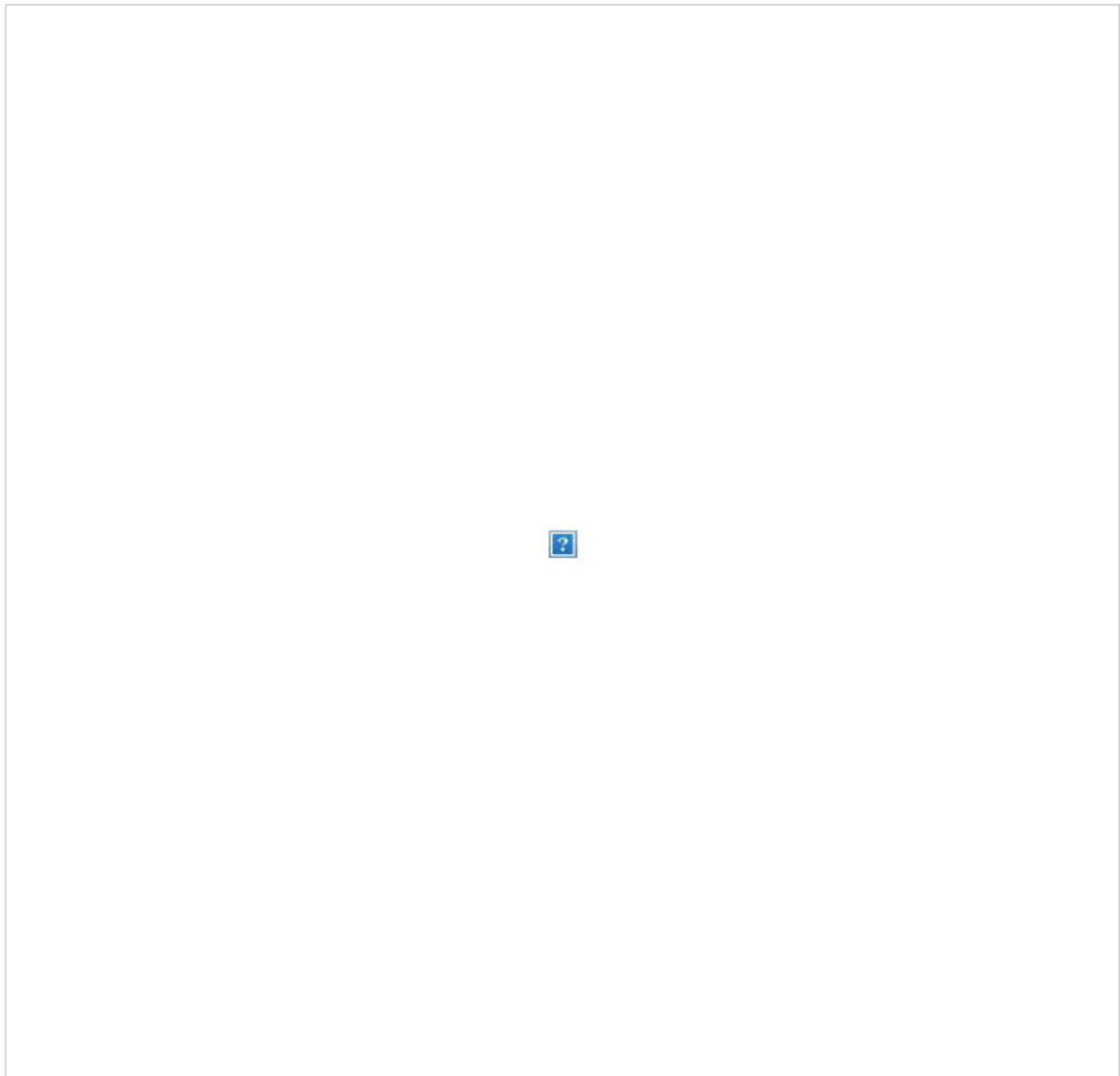

Dear [REDACTED],

On 17 June 2020, we sent you minutes of the meeting (attached) that gave an overview of the [LBWF+LBN-LTN scheme \(All Areas \[1 to 4\]\)](#); and an outline of various agreed design parameters and emergency service response procedures.

We have now substantially completed the implementation of Areas 1 and 2; and we are now preparing to implement Areas 3 and 4 in late October 2020.

Please see plans below + attached, which illustrate the scheme proposals. The proposals that are to be implemented are based upon the previously agreed scheme, however, since then we have designed a more permeable network of modal filters to allow improved emergency service access via the implementation of an increased number of lockable bollards at various modal filter locations (50% of modal filters are now permeable).



The lockable bollard/modal filter locations are illustrated by the yellow symbols on the plan, and in the yellow cells on the spreadsheet below.
