Freedom of Information request: FOI2022/00272

Thank you for your email of 19 May 2022 requesting information about admissions procedures for named programmes.

The University of Edinburgh is a global university, rooted in Scotland. We are globally recognised for our research, development and innovation and we have provided world-class teaching to our students for more than 430 years. We are the largest university in Scotland and in 2020/21 our annual revenue was £1.18 billion, of which £324 million was research income. We have over 45,000 students and over 16,000 staff. We are a founding member of the UK's Russell Group of leading research universities and a member of the League of European Research Universities.

Admissions for named programmes

You asked for information related to the weightings allocated to A-Level grades, GCSE grades and personal statements for the 2022/23 undergraduate programmes in the following named programmes; Artificial Intelligence (BSc) G700, Artificial Intelligence and Computer Science (BSc) GG47, Computer Science (BEng) G401, Computer Science (BSc) G400, and Computer Science and Mathematics (BSc) GG14. You also asked if this weighting is similar to previous years.

To answer your request I contacted the <u>College of Science and Engineering</u> College (CSE) Office.

The University does not hold any information to answer your request. Personal statements and qualifications for applications for the programmes named in your request are not 'weighted'; they are assessed against agreed selection criteria for each degree. All applicants who meet/are predicted to meet the minimum entry requirements for a programme go into the selection pool. Further <u>information on the selection process</u> is available on the University's website.

Right to review

If you are dissatisfied with this response, you may ask the University to conduct a review of this decision by contacting the University's Records Management Section in writing (e.g. by letter or email) or in some other recorded form (e.g. audio or video tape). You should describe the original request, explain your grounds for dissatisfaction, and include an address for correspondence. When the review process has been completed, if you are still dissatisfied, you may use the Scottish Information Commissioner's guidance on making an appeal to make an appeal to the Commissioner.
