Thank you for your request for information received on 15 March 2017. Please find information requested below.

Can you please confirm where if online and which newspaper(S) you advertise all your public notice, including planning TROS Path Diversion to name a few.

Please be advised that The Traffic Team deals with Traffic Management Orders (TMO's) which are the same as Traffic Regulation Orders (TRO's). TMO is the terminology used in London. TRO is used elsewhere in the country. They are essentially the same as each controls or regulates traffic movement or parking. They therefore apply to the public highway.

There is legislation that requires permanent TMO proposals to be advertised in a local paper and the London Gazette. The local paper we use is the News Shopper for this area.

Please note that copies of notices published in relation to TMO's are available to view on the Council website and are updated weekly.

For TMO's we are also required to fix public notices in the vicinity of the proposed changes and consider writing to those directly affected.

The Council has a public notices page in the News Shopper every week where its notices (including rights of way diversions) are published. There is a link in the Bexley Bulletin each week to these notices. Some notices are also required to be published by legislation in the London Gazette.

If your enforcement register is available online and if not ascertain how many planning enforcement notices(all) were served in 2016/2017 and give a copy of register

During the period January 2016 to date 2 Enforcement notices have been served.

The Enforcement Register is not available online but is available for inspection at our offices at 2 Watling Street, Bexleyheath between the hours of 10am and 4pm Monday to Friday.

If your TROS are available online and if not do you have a list of consultees.

Please see attached list. Please note that we seldom consult all teams provided on the list, but rather select relevant organisations to consult. For example it includes bus companies and neighbouring Councils, however if the proposals do not affect buses or roads in adjacent Boroughs they would not be consulted.
