Stopping Order based on Section 247 Town and Country Planning Act. Currently still HMPE as stopping up was conditional that works were up to standard but still some issues. Advertised by Department for Transport

#### **Birmingham City Council - Stopping up of Holiday Street/Suffolk Street Queensway, Alpha Tower and Crowne Plaza (Proposed 2015)**

A small portion of Holliday Street only was stopped up in 1967 based on Section 247 Town and Country Planning Act. Advertised by the then Department for Transport. Nothing else stopped up on these areas

#### **Birmingham City Council - Stopping up of Redditch Road/Green Lane/Foyle Road and Teviot Grove, Kings Norton (Proposed 2015)**

Stopping Order based on Section 247 Town and Country Planning Act.

Currently still HMPE as stopping up was conditional with some conditions still outstanding. Advertised by Department for Transport
