Will have a chat tonight about this but quick responses;

- 1) Would love to see the file on the previous attempts.
- 2) I am sure democratic services will know the breakdown of the signatures, but ultimately this is now irrelevant as the decision is one in each of the towns and last night's consultation in Broadstairs showed that the youngsters move around the whole of the district to each of the parks anyway.
- 3) We totally intend to liaise with all residents surrounding the proposed sites for development but no point until we have outline plans. That way if there is valid opposition we can adapt accordingly but not worth just going to discuss 'what ifs'. There is loads we can do to minimise the impact on local houses such as physical screening and of course engagement work with the users.

I look forward to meeting you and the group in due course so we can consider any concerns. I hope to be able to reassure you that the plans will be considerate of all parties.

- 1) Not all of the concrete area will have tricks and banks as we definitely still want to cater for beginners or younger children.
- 2) I would happily meet the radio control car group to suggest other suitable areas/options. Again not all of the concrete area is planned to be used for skate/BMX as the budget is limited.
- 3) Whilst we have not decided on types of screening yet, one of the benefits of refurbishment is to use the correct type of skimmed concrete. This has no lips/connections so reduces the noise from wheels hitting them e.g. noise from the equipment. Noise from increased number of people using the facility is a consideration but I would argue that it would be difficult to hear noise of the skaters above the road and train station already. Anti-social noise would of course be followed up in the usual way by Council departments. We would not be installing lights at the venue so the usage of the park will decrease in winter months (7 months of the year). During the summer we will actively engage with the users to consider local residents and work with senior members of the group to 'self police'.
- 4) Having spent more time at the site last night, my current thought process is now to move the basketball posts to edge of the concrete area as there will be plenty of space.

I really don't think refurbishing this corner of the park will impact on ALL other users. There is plenty of space and my current understanding is that there will be no further loss of park to the football club. I agree that all users work together at the moment and don't envisage this changing with new facility.

As Cllr Tomlinson says we will be in touch soon once initial plans are drawn up. In the meantime I would be interested in seeing the file with concerns about previous plans so we don't fall into the same problems.

His Since our resident consultation at Hartsdown, we have updated users with information that came to head from user group and resident meetings..

The users were very open and welcome to any measures we were to put in to ensure that residents did not suffer disturbance or nuisance, for example,

We have also received a quote from a supplier for the cost of 'starting again' and building a brand new skate park from scratch in the middle of the park. This quote came from

The cost came out at least £50k more than if we were to build on the existing site, they said a whole 'concrete style bowl' park with excavation and laying foundations and base would be in the region of 115k.

Considering we only have 150k to be split between 3 parks we do not see this as a commercially viable, or a practical option. This cost does not take into account the reverse work of making the current dip an open green space; which would be a requirement for the loss of park space.

We are now progressing by looking at viable options for suitable and attractive screening to ensure the resident's needs and concerns are fully taken into account.

If we can source some good examples of appropriate screening that will compliment the park, then our next step is to ask manufacturers to design us a park that is suitable for half the area of the dip (not Super park as we are building two more parks in Broadstairs and Ramsgate respectively), with the other half being used for basketball and other leisure activities, like perhaps the remote control cars that have been mentioned?

I apologise that this information is only coming to you now but I hope it shows you that we are taking the residents views very seriously and are not rushing ahead with the project regardless.

- 3) Whilst we have not decided on types of screening yet, one of the benefits of refurbishment is to use the correct type of skimmed concrete. This has no lips/connections so reduces the noise from wheels hitting them e.g. noise from the equipment. Noise from increased number of people using the facility is a consideration but I would argue that it would be difficult to hear noise of the skaters above the road and train station already. Anti-social noise would of course be followed up in the usual way by Council departments. We would not be installing lights at the venue so the usage of the park will decrease in winter months (7 months of the year). During the summer we will actively engage with the users to consider local residents and work with senior members of the group to 'self police'.

4) Having spent more time at the site last night, my current thought process is now to move the basketball posts to edge of the concrete area as there will be plenty of space.

I really don't think refurbishing this corner of the park will impact on ALL other users. There is plenty of space and my current understanding is that there will be no further loss of park to the football club. I agree that all users work together at the moment and don't envisage this changing with new facility.

As Cllr Tomlinson says we will be in touch soon once initial plans are drawn up. In the meantime I would be interested in seeing the file with concerns about previous plans so we don't fall into the same problems.

Many thanks for such a prompt update and for your email just before the meeting - really appreciate your help with all this. I was desperate to come over but thought it best to stay away (and got a lot of housework done to get rid of my frustration!). I did see the group and also the bikers and indeed a couple of brave souls (neighbours) who went over - I was not prepared to risk it after last time - after all I am 20 years older now and don't move quite so fast! As far as I am aware both indeed have issues with this proposal.

With regard to your previous email and Mr Cassell's comments - just a few points:

- Not all bikers that use this part of the park are BMX-ers there are a lot of smaller children (who would have been at home having tea and getting ready for bed at the time of the meeting) and who would not be able to use the area due to the necessary speed that the skate boarders/bmx-ers need to achieve before being able to do stunts.
- Remote control cars do not work as well on grass, otherwise the guys that have these would use the grass already there.
- Regarding the physical screening I fail to see how this will minimise the noise issue unless it is a very high unsightly
 type of screening. Also please see back to my point in a previous email that if wooden fencing was used, this would
 probably be dismantled (as in the case of the toilet door and cubicle doors in 1990) to make secondary ramps which was
 a big litter problem before and also impossible to secure out of hours.
- If the basketball posts are moved to the tennis courts, this will reduce again the number of tennis courts half of them have already been lost as a car park.

I think it is important to bear in mind that the park is for ALL users - and the space open to the general public to play, walk dogs etc is already being eroded as there is a huge chunk being used by Margate Football Club for the 5-a-side pitches (and possible plans for another full size pitch I believe along the Tivoli Park Avenue side of the park) and now restricted from general use by members of the public. Whilst I appreciate that the skateboarders have a right to specific space too, with the current concrete area, all users rub along very well together and all our catered for.

Hi All

Following on from the resistance shown at the follow-up Hartsdown residents meeting last week there is a need to revisit the project for the Margate site.

We released the tender documents to the 5 shortlisted companies last week as well and so I will be asking our contract management company to release notification to the bidders to say that the Hartsdown site is suspended from the tender until further notice.

This carries some risks on the project.

- 1) The original petition that was received by full council asked for a skatepark to be built at Hartsdown Park.
- 2) The decision was to go for 3 parks, one in each town, but with this hold up we are likely to be building the other towns prior to Margate where the plea originated from.
- 3) The delay could hold the entire project up if it is not removed from the tender. However if Margate site is removed from the tender then it is likely a new procurement process will need to be conducted and might not bring the economies of scale from doing all at same time.

We have held public meetings for users and for residents in each area. The Broadstairs and Ramsgate meetings didn't have high attendance but those that attended were in favour and ward Cllrs are aware of the projects. The parks don't need planning permission as they are on Council land, do not exceed 4m in height or 200 cubic metres of land movement. There were press releases issued at the time of the decision that mentioned Hartdown Park and the Warre Rec but not since decisions were made on the three sites.

In hindsight, I am a little worried that if all of the sites proposed have gone under the radar of residents e.g. not advertised through planning, low attendance at resident meetings that we may encounter problems at the stage of building. I would therefore welcome a discussion on the Margate site and whether or not we should publicise the proposed sites further.

Unfortunately tomorrow is my last day in office for a week. Can we look to get together on Monday 19th August at 11am please.

Thank you for the opportunity for residents to give feedback/comments on the re-siting of the proposed skateboard ramp. It is very much appreciated.

The new location you are suggesting does go a *little* way to appeasing some of the neighbours, although we are at a loss as to why the plan is still to site this skateboard park so close to residents, which is bound to cause parking and noise issues and we are still very firm in our opinion that it should not be sited in that part of the park at all. We still have the following reservations, most of which applied to it being sited whether it be in the dip or behind the pavillion, whilst appreciating that the pavillion building may offer *some* natural screening/sound diminishing. Some of our major concerns with the new proposed site are as follows:

- 1. There still needs to be sufficient security to stop any use at night and strict timings need to be set out and adhered to/enforced. We would need to have an "accountable" person that we could contact "out of hours" should these timings not be adhered to or should fencing (both for security and noise elimination purposes) be breached or damaged.
- 2. There still needs to be absolutely no lighting of the proposed skateboard ramp, or of the dip after dark (the "daylight" bulb which has still not been changed in the lamp-post opposite All Saints Avenue is still encouraging baskbetball to be played in the dark in the dip, i.e. 1.00a.m. over this weekend).
- 3. There are still concerns over car parking on double yellow lines in All Saints Avenue this occurred before and there is no reason to think it won't happen again by relocating the ramp a few yards further over this caused traffic hazards, particularly by the Naylands junction and the Police were too busy to be able to deal or respond to this type of incident.
- 4. There needs to be sufficient signage to ensure that the dip not be used at all for skateboards if the proposed new site of the ramp is a success, we feel that the "overflow" of users may still use the dip and may still build secondary ramps and of course use these ramps "after hours" too.
- 5. One new concern is that, if, as indicated previously, the pavillion be used for skateboard shop/cafe bar etc with presumably a supply of electricity, what is to stop speakers/music being set up and being played loudly, even during legal opening times this happened on a few occasions before with the power being supplied from the old golf storage hut.
- 6. We think wherever the skateboard ramp is sited, a review date should be set, e.g. once the skateboard park has been open for a month, to address any problems not being addressed regarding of any of the above or others that might arise.

I am sure you can appreciate that our concerns are still valid, even with the proposed re-siting of the skateboard park. When we originally met with you and we suggested putting the ramp where the cricket pitch used to be, i.e. in the middle of the park, one of your main reasons for not doing this was that the cost of digging out the cricket pitch area would be overbudget and would leave little funding to enable the actual skateboard ramp to be built - we fail to see how it will cost anymore to dig out the grass cricket pitch area, (which is still the best option regarding proximity to residential housing) as opposed to digging out the newly proposed site by the pavillion and also would not involve the moving of the path/walkway/lighting through the park - surely the costs will be the same.

That said, we do appreciate all the work that has gone into trying to work with us to negate the huge impact that this will cause us.

Thank you for the comments. I had hoped that the new site was the solution to the problems as we are keen to find a solution for all parties. I have commented on the points below much of which I feel I answered at the public meetings.

- 1) The parks will be low level picket fenced but not locked. The very nature of these facilities are that they are open access. We cannot 'police' them out hours, this is the same for ball courts across the district in residential areas but where issues arise we can do is temporary surveillance to resolve issues and identify individuals causing the ASB.
- 2) There is no plan to light the parks at all. The 'daylight' bulb you pay reference to is, as I understand, a KCC street light and nothing to do with TDC. I am making enquiries with KCC about this.
- 3) The majority of the users will be pre-driving age limit but we recognise that some will drive to the skateparks. Signage in the park will remind users of where to park and should there be major parking issues then these could and should be reported to TDC parking so enforcement can take place. Barring an organised event where traffic management plans would be made, we estimate that there are likely to be less than 40 users at any given time.
- 4) It is undecided what will happen to the dip. I share your concerns that there could be overflow and this is something we would need to consider.
- 5) Any future options for the pavilion would factor this in. Leases could have conditions relating to use to mitigate this.
- 6) Any issues that arise from the location of a Skatepark would be dealt with by the relevant dept at the time e.g. community safety for anti-social behaviour or parking for infringements etc.

With regard to locating elsewhere in the park, yes finance was one of the considerations. It will be more expensive to build in the newly proposed area and would be the same anywhere in the park. However as Cllr Johnston said at the public meeting the key determinant for siting it elsewhere in the park was a loss of usable open space. The reason for selecting the area in front of the pavilion was that it would not encroach on other activities too much whereas a site in the middle of the park would.

I will be meeting with other officers in the next few weeks to look at the next steps and so would welcome any further steer from residents following my points above.



Members have agreed that the Margate location will change to the area just in front of the old changing block prior to reaching the tennis courts. We can supply you with this location plan.

Martyn has also nudged the other two locations slightly due to car park issues at Ramsgate and the proximity of housing in Broadstairs.

The new location at Margate will increase the contract value as more dig required and banking to be formed etc. It has been proposed to keep it transparent that we will re issue tenders to the tenderers for resubmission with a slightly higher budget and revised locations. We still have the following reservations, most of which applied to it being sited whether it be in the dip or behind the pavillion, whilst appreciating that the pavillion building may offer *some* natural screening/sound diminishing. Some of our major concerns with the new proposed site are as follows:

- 1. There still needs to be sufficient security to stop any use at night and strict timings need to be set out and adhered to/enforced. We would need to have an "accountable" person that we could contact "out of hours" should these timings not be adhered to or should fencing (both for security and noise elimination purposes) be breached or damaged.
- 2. There still needs to be absolutely no lighting of the proposed skateboard ramp, or of the dip after dark (the "daylight" bulb which has still not been changed in the lamp-post opposite All Saints Avenue is still encouraging baskbetball to be played in the dark in the dip, i.e. 1.00a.m. over this weekend).
- 3. There are still concerns over car parking on double yellow lines in All Saints Avenue this occurred before and there is no reason to think it won't happen again by relocating the ramp a few yards further over this caused traffic hazards, particularly by the Naylands junction and the Police were too busy to be able to deal or respond to this type of incident.
- 4. There needs to be sufficient signage to ensure that the dip not be used at all for skateboards if the proposed new site of the ramp is a success, we feel that the "overflow" of users may still use the dip and may still build secondary ramps and of course use these ramps "after hours" too.
- 5. One new concern is that, if, as indicated previously, the pavillion be used for skateboard shop/cafe bar etc with presumably a supply of electricity, what is to stop speakers/music being set up and being played loudly, even during legal opening times this happened on a few occasions before with the power being supplied from the old golf storage hut.
- 6. We think wherever the skateboard ramp is sited, a review date should be set, e.g. once the skateboard park has been open for a month, to address any problems not being addressed regarding of any of the above or others that might arise.

I am sure you can appreciate that our concerns are still valid, even with the proposed re-siting of the skateboard park. When we originally met with you and we suggested putting the ramp where the cricket pitch used to be, i.e. in the middle of the park, one of your main reasons for not doing this was that the cost of digging out the cricket pitch area would be overbudget and would leave little funding to enable the actual skateboard ramp to be built - we fail to see how it will cost anymore to dig out the grass cricket pitch area, (which is still the best option regarding proximity to

residential housing) as opposed to digging out the newly proposed site by the pavillion and also would not involve the moving of the path/walkway/lighting through the park - surely the costs will be the same.

That said, we do appreciate all the work that has gone into trying to work with us to negate the huge impact that this will cause us.

Thank you for the comments. I had hoped that the new site was the solution to the problems as we are keen to find a solution for all parties. I have commented on the points below much of which I feel I answered at the public meetings.

1) The parks will be low level picket fenced but not locked. The very nature of these facilities are that they are open access. We cannot 'police' them out hours, this is the same for ball courts across the district in

- residential areas but where issues arise we can do is temporary surveillance to resolve issues and identify individuals causing the ASB.
- 2) There is no plan to light the parks at all. The 'daylight' bulb you pay reference to is, as I understand, a KCC street light and nothing to do with TDC. I am making enquiries with KCC about this.
- 3) The majority of the users will be pre-driving age limit but we recognise that some will drive to the skateparks. Signage in the park will remind users of where to park and should there be major parking issues then these could and should be reported to TDC parking so enforcement can take place. Barring an organised event where traffic management plans would be made, we estimate that there are likely to be less than 40 users at any given time.
- 4) It is undecided what will happen to the dip. I share your concerns that there could be overflow and this is something we would need to consider.
- 5) Any future options for the pavilion would factor this in. Leases could have conditions relating to use to mitigate this.
- 6) Any issues that arise from the location of a Skatepark would be dealt with by the relevant dept at the time e.g. community safety for anti-social behaviour or parking for infringements etc.

With regard to locating elsewhere in the park, yes finance was one of the considerations. It will be more expensive to build in the newly proposed area and would be the same anywhere in the park. However as Cllr Johnston said at the public meeting the key determinant for siting it elsewhere in the park was a loss of usable open space. The reason for selecting the area in front of the pavilion was that it would not encroach on other activities too much whereas a site in the middle of the park would.

I will be meeting with other officers in the next few weeks to look at the next steps and so would welcome any further steer from residents following my points above.

The new location you are suggesting does go a *little* way to appeasing some of the neighbours, although we are at a loss as to why the plan is still to site this skateboard park so close to residents, which is bound to cause parking and noise issues and we are still very firm in our opinion that it should not be sited in that part of the park at all. We still have the following reservations, most of which applied to it being sited whether it be in the dip or behind the pavillion, whilst appreciating that the pavillion building may offer *some* natural screening/sound diminishing. Some of our major concerns with the new proposed site are as follows:

- 1. There still needs to be sufficient security to stop any use at night and strict timings need to be set out and adhered to/enforced. We are now in a position to confirm the locations of each of the three skateparks following numerous discussions with officers and Cllrs on the matter. Cabinet have agreed that the Hartsdown location will not be the dip area initially proposed and will be positioned in the second option which is attached to this email. A press release will be issued soon when we are in a better position to give dates for construction etc.

We feel this gives due diligence to all considerations as the pavilion will give additional noise screening and is further away from the houses. We also did not want to encroach on the middle areas of the park as this will reduce the options for youth sports activities and one-off events using the park in future.

Further to my email below, I can confirm that TDC will remove the concrete sides to the dip to discourage usage of the area as an overflow from the new skatepark. I know this was a concern of the residents and we feel this is important. The concrete base will be left for basketball and the other uses that residents stated were important in your opposition to the skatepark, such as children learning to ride bikes and the use of radio controlled cars.

I am unsure if removing the sides and leaving the base is a good idea. There may well be run off from the solid sides into the lower concrete unless it is given a lip or some engineering solution. The site already gives rise to problems for cleansing who cannot easily clean or sweep it. Sadly I think it might be best to get rid of it totally. One way to do this cost effectively would be to break up the concrete and then use chalk spoil from the cemeteries to infill and then surface the top 150mm for grass seeding once the levels have settled.

Model cars gave rise to complaints in Ramsgate seafront where they were close to houses - perhaps we could look at an area on the old pitch and putt course a bit further into the park?
