Good Afternoon [REDACTED],

Hope you have been keeping well these past couple months.

I just wanted to update you on the fact that I will be returning to work for one day a week starting today (22<sup>nd</sup> of July) as part of the governments flexible furlough scheme. As my working hours are still significantly reduced, support will continue to be offered by the memberships team to ensure that you receive the full support that your Diversity Champions membership entitles you too. Moving forward, as you are potentially aware due the current global situation, and the specific challenges that organisations would have had in submitting to the Workplace Equality Index, we have made the decision not to open the 2021 Index for submission. In lieu of this, we have developed a [Workplace Equality Index Support Series](#) that we will be running through the next eight months meant to help you continue on your journey of LGBT inclusion.

The first part of the series will be an opportunity to learn about the new criteria (including our Gold, Silver and Bronze awards) that we have developed as well as receive direct feedback on questions that you wish to ask. This Q&A session will be taking place on August the 21<sup>st</sup> and I would highly recommend booking your spot [here](#). This will be followed by our Criteria Consultancy sessions which will allow us to have a two hour, in depth meeting covering three areas of the index of your choice and receive best practice advice from myself. The series will conclude with a Common Challenge Webinar series which will have us sharing best practice, common pitfalls and effective solutions identified in the consultancy sessions.
