I can confirm that Health Education and Improvement Wales (HEIW) has completed a search of its records and established that it does hold information falling within the confines of your request. HEIW has not provided funding to Stonewall in the form of direct grants for unlimited purposes.

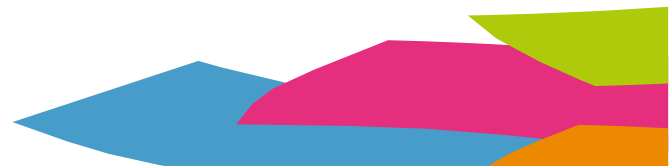
b. direct grants for limited purposes (in that event, stating the purpose);

HEIW is a member of the Stonewall Diversity Champions Programme and the payments made during 2019-2021 relate to an annual membership fee.

The payment relates to the annual membership fee. HEIW has recently taken the decision to renew its membership of the Stonewall scheme.

No contractual or legal shortfalls have been identified and so no steps are being taken.

4. In respect of the payments referred to in 1 above, please state:

- a. What criteria were applied in deciding to make payments by way of direct grants;**

HEIW has not made payments to Stonewall in the form of direct grants.

- b. What tendering process was conducted with regard to the provision of goods or services;**

The Stonewall Diversity Champions Programme operates on a voluntary membership basis which participants join through payment of an annual membership fee. This is not a 'procured' provision of goods or services.

- c. What alternative suppliers of goods or services were considered.**

The Stonewall Diversity Champions Programme operates on a membership basis. HEIW's decision in 2019 was based on whether it wanted to become a member of the Stonewall Programme or not. However, HEIW membership is reviewed annually and the benefits of continuing to be a member or not will be considered when our membership falls due for renewal in September 2022.

I hope you find this information useful. If you are not satisfied that all of the information you have requested has been provided, or because of the way your request has been handled, you have the right to request a review. This would be looked into in accordance with the Information Commissioner's Office (ICO) guidelines, which state that a request for review should be received within two months of you receiving HEIW's response to your request for information. The ICO also recommends that public authorities carry out internal reviews within 20 working days. 
