Thank you for your request for information received on 20th May 2016, regarding NHS Jobs - information on advertised vacancies. Please find the response from Cwm Taf University Health Board set out below:

Please provide me with data on all vacancies advertised through you on an excel spreadsheet with one row for each vacancy and with the following column headers:

Please provide data for the last five years up to now (i.e. where the post was advertised from January 1st 2011 onwards). Please exclude vacancies where the application has not yet been closed.

Our response:

Please note, NHS Jobs 2 went live in March 2014 therefore, we are only able to provide data from this date onwards.

On average 20,000 adverts are placed on NHS Jobs each month. In trying to obtain the information you require, we have experienced technical issues due to the size of the data files. Prior to us making further IT arrangements to receive the data in full, please see attached a small section of the data you have requested.
