I refer to your request of 20/03/2020 and I apologise for the delay in responding.

Regulation 11(2) and (3) of the Environmental Information (Scotland) Regulations 2004 provides that a Scottish public authority shall not make personal data available where it constitutes the personal data of a third party and to do so would contravene any of the data protection principles. The information you have requested constitutes the personal data of a third party and to make it available would contravene the first data protection principle.

For this reason I refuse these parts of your request.

In regards to the selling price, Regulation 10(5) (e), of the Environmental Information (Scotland) Regulations 2004 provides that a Scottish public authority may refuse a request to make information available if its disclosure would or would be likely to prejudice substantially the confidentiality of commercial or industrial information where such confidentiality is provided for by law to protect a legitimate economic interest. Disclosure of the information you have requested would or would be likely to prejudice substantially the legitimate economic interests of the companies involved and the Council.

I therefore refuse this part of your request.

The information which we can provide is contained in the documents attached.

Please provide us with any correspondence between yourselves & any other party (eg SEPA, Scottish Water, Persimmon) and also internal council communication, regarding the sale & development of the Kingspark site, Gillburn Road, from the date of the Reporter's decision to allow the development until the present. We specifically want the purchase price included.

How We Handled Your Request

We believe you have asked for environmental information as defined in the Environmental Information (Scotland) Regulations 2004 ('the EIRs'), so we are dealing with your request under those regulations. To be able to use the EIRs, we must apply an exemption under section 39(2) of the Freedom of Information (Scotland) Act 2002 ('FOISA'). The Scottish Information Commissioner's guidance recommends that public authorities apply this exemption to environmental information and handle requests under the EIRs.

Your Right to Appeal

Your requirement for review will be dealt with by a Senior Officer who will reply to you in writing promptly and in any event within 20 working days. He/she may:-

- confirm my decision with or without modification;
- substitute a different decision for my decision;

and will give you their reasons for so doing. If you are unhappy with the Senior Officers decision you may then appeal

to the Scottish information Commissioner. You must submit your appeal to the Scottish information Commissioner
