I refer to my telephone discussion held with [REDACTED] today re: both our Kingspark and Stewarts developments in Dundee in relation to Public Artwork.

As anticipated, [REDACTED] has now confirmed that the figures presented were acceptable and I'd be grateful if this enables the following Planning Conditions that are shown as suspensive to be agreed as addressed to a stage where we will not be exposed in a Planning sense when we commence works on the understanding that we can now meet and progress with John in a timely manner.
