This is now very pressing for Lucy's report and for HLF approval of the procurement process. Can we please receive both documents by close of business on Friday.

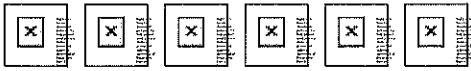
