Your request has been handled under the Freedom of Information Act 2000 (FOIA).

- 1. How many complaints by Medway council staff members and members of the public have been made about Yvonne Kapungu during her employment at Medway council?
- 2. How many people was Yvonne Kapungu directly responsible for supervising? Was Yvonne Kapungu a team manager?
- 3. Was Yvonne Kapungu asked to leave her role at Medway council or did she resign?
- 4. How many children has Yvonne Kapungu removed in to care during her time at Medway?
- 5. Has Yvonne Kapungu declared an interest in any businesses such as Solicitors firms whilst working at Medway?

## Response:

I can confirm that we hold the information that you have asked for in questions 1, 3, 4 & 5 of your request, but in this case we will not be providing it to you as it is exempt from disclosure.

We are not obliged, under section 40(2) of the Act, to provide information that is the personal information of another person if releasing would contravene any of the provisions in the Data Protection Act 1998 (DPA). In this instance we believe that the release of this information would contravene the first data protection principle and therefore section 40 (2) is engaged.

The terms of this exemption in the Freedom of Information Act mean that we do not have to consider whether or not it would be in the public interest for you to have the information.
