I wanted to get in touch to introduce myself and confirm the latest position on DfE response to Matter 55 of the New London Plan. I know you were previously in touch with on this but he has recently moved from DfE to a new role at Defra, so I will be the point of contact on this going forward. I've also just realised it appears we have incorrectly referenced it in previous correspondence with you as Matter 54, but fortunately GLA have published the response under the correct Matter (55) online.

In any case, I've attached for your reference a copy of the final response we submitted (through MHCLG). This refers to some revised wording we anticipated GLA would make, which they have now done, so I will provide an update to our statement to the Inspector before the hearing date. I've seen you have made reference to the same GLA revisions in your statement on Matter 55.
