Thanks very much for your email, my apologies for the delay in getting back to you. I look forward to receiving more information about the proposed changes to S5.

Further to our discussion about sports lighting, we would like the sport section to further highlight the important role of sports lighting in increasing people's ability to be active and the wider associated health benefits. Delivering sports lighting enhances the availability and viability of the facilities and the health and wellbeing benefits it provides. We are concerned that without further encouragement in the plan Policies D12 and D13 and 3.13.6 might make it more difficult to secure planning permission for sports lighting, which can already be difficult for sports clubs in a number of London Boroughs.

Sport England considers that sports lighting should be supported unless the impact can't be mitigated against.

I would therefore like to put forward the following revision to paragraph 5.5.7;

'Lighting of outdoor sports facilities is important to improve their availability to the community and their long term viability. This can greatly enhance people's ability to be active and secure the wider benefits of sport, including improving health and well-being.

The form of lighting required will depend on the facility and its use and efforts should be made to minimise its impact on neighbours and biodiversity. Sports lighting should be supported unless it can

be clearly demonstrated that the impact will be unacceptable and cannot be addressed through mitigation measures.'
