You should be aware that we have just received a parallel request from Thomas Cook to consent to the granting of security over their shares in The Airline Group as part of their debt financing process. They are seeking agreement by Thursday 22nd. We are currently taking appropriate legal advice and are discussing with Airline Group tomorrow (Tuesday). Whilst not wanting to hinder the Thomas Cook financing exercise, this raises more difficult issues in relation to non-airlines potentially owning shares in Airline Group. Background

- 4. Thomas Cook is one of the seven airline shareholders in Airline Group Limited. Airline Group is the strategic investor in NATS, holding 42% of the shares and appointing the majority of the Directors to the NATS board.
- 5. Each Airline Group shareholder entered into an individual agreement with the Secretary of State, placing some obligations on them with regard to the operation of their shareholding, covering such matters as managing conflicts of interest, confidentiality of information, and supporting the role of Airline Group as Strategic Partner. These are set out in a Deed of Covenant between each Airline Group shareholder and the Secretary of State.
- 6. Under the terms of the Deed of Covenant, Thomas Cook needs Secretary of State's consent to transfer, or to grant security over, its shareholding, such consent not to be unreasonably withheld or delayed. In the event of a transfer, any new shareholder must enter into a new Deed of Covenant no less favourable to Secretary of State.
- On 25 November, Thomas Cook announced that it had reached agreement with its banking group for a new £200m bank facility available until April 2013. [Redacted under FOI Act s 43].

- 8. On 19 December Thomas Cook has formally sought Secretary of State consent and provided a proposed form of consent. In parallel Thomas Cook is also seeking the consent of the other shareholders in Airline Group, as required under the terms of the Airline Group shareholders' agreement. Both consents have been requested by 22 December. Secretary of State's consent is required for the security over the shares but not the loan notes.

7.5 Do the financial difficulties facing Thomas Cook have any impact on the reforms? Will the reforms help Thomas Cook's?

Clearly the reforms can't be based around the circumstances of any one business. Like other ATOL licensed businesses, Thomas Cook will have to comply with the new regulations when they come into force, for example by providing ATOL certificates when they sell an ATOL protected holiday or flight.

7.6 What if Thomas Cook goes insolvent?

We can't comment on the position of individual businesses. As would be expected in its role as ATOL regulator, the CAA monitors closely the finances of all major ATOL businesses including Thomas Cook.
