## FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: VEHICLE HISTORY.

We refer to your email dated 3 July 2020 to the Ministry of Defence Police which was acknowledged on the 6 July 2020.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

"I have recently purchased a vehicle from Robin Beeston Ltd., and I believe the vehicle to have been previously owned and used by the MoD. Could you please confirm that the vehicle, Mercedes Vario 814D using registration number EU53ZJX (VIN-WDB6703532N111630) was indeed owned by yourselves and supply the following information:

- All service and repair history documentation available
- Approx. dates this car was used as a police car
- MOT history and mileage the vehicle covered during this time
- What it's general use was
- Whether it was sold with or without damage or faults
- If the odometer (mileage clocks) were changed before or after sale
- Any confirmation of ownership
- Any photographs that may be available

Any available information relating this vehicle will be greatly appreciated."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do not hold information in scope of your request.

The maintenance for vehicles is contracted to BTFleet via Babcocks International and they hold all service records.
