"Details of injuries suffered by any staff/MSPs at work in the Scottish Parliament for the most recent 12 month period. Could you please provide me with details of the injury including how it is believed to have happened, the date it took place and if medical treatment was required. Also can you tell me if any compensation claims have been made (and amount paid out if the claim has been settled)".

Your request was received on 24<sup>th</sup> February 2017 and has been handled in accordance with the Freedom of Information (Scotland) Act 2002.
