Information from school website: Good and informative website. Very parent friendly in terms of useful information for any new starter. Very good Prospectus but slightly dated. Good on history of the school. Fully compliant in all key areas regulations September 2017.

Local Childrens Safeguarding: Wandsworth. Graded Inadequate overall in December 2015. 5 monitoring visits since. Last one in September 2017 showing improvements overall and quite positive report.

Local media and wider search: Nothing of note.

Safeguarding and Child Protection policy on website: Yes up to date version October 2017. Very thorough and lots of good information and links to e-safety and staying safe on-line..

Whistleblowing: Could not find it but has an Allegations against staff policy.

Governance: Compliant. Quite basic and look like an experienced set of governors.

Values: Collective worship looks strong with assemblies every day. Values assembly.

Attendance: Attendance Policy 2017 a clear document. School operates a penalty system for late collections after 3.20pm etc. Unusual for a primary school.

Pupil Premium: Called Disadvantaged Strategy detailed and up to date for the last 2 years funding. Needs updating. Quite good overall.

Sports Premium: Same as above.

PIR: Link to March 2013 very prominent

School Improvement Plan: Could not find it.

SEND: Very clear policy and SEND statement equally clear for parents to understand.

Policies: A list of all areas required all there and vast majority up to date.

Curriculum: Very comprehensive Curriculum Map for every class and includes the Foundation Stage. Good feature.

Homework: Some ICT resources. Best part is the school recommendations well laid out for parents and pupils and again needs updating.

Parents: Good prospectus for parents very helpful. Best parts are the colourful photos and history. Lots of useful information for any new parent.

Children: Under About Us there is a detailed Gallery of a wide range of events within and external to the school. Rest of events need updating.

Behaviour: October 2017 and called Positive Behaviour Management Policy. Some good links to Pastoral Care as well.

Health: Little bit under Parent Info and some bit on healthy meals etc.

Key Questions Arising:

1. Safeguarding as Wandsworth is Inadequate overall and has been for some time. What systems are in place within the school?
2. What is the effect of the penalty system in maintaining punctuality and attendance overall?
3. How are Values assemblies promoting personal development, behaviour and welfare ?
