If we assume the ward office AC units are on for 10 hours a day during summer (90 days) these will cost £162 each P.A.

The seminar & tribunal room, assuming they're on for 4 hours a day during summer will be £65 each P.A.

Assuming the clinic room is on for 4 hours a day 6 months of the year, this will be £130 P.A.

Based on the above the total cost to the trust in increased energy consumption will be approx. £584 P.A.

Dear Occupational Health,

Please could you investigate the possibility of improvements such as air conditioning to this room.

Our pharmacy technician had to work for several hours in this room yesterday in temperatures of around 28 degrees. He was forced to go home early due to feeling unwell. He reports to me that he possibly became dehydrated due to the excessive temperatures in that room. Our pharmacy technicians are perhaps the only class of staff required to work in there for hours at a time.

In the meantime we will provide drinks to top up on fluids regularily throughout the day.

We have been monitoring the temperature (as the high temperatures are unsuitable for medication storage) so we can provide information on the temperature in that room.
