

# The Freedom of Information Act 2000

**Public Information Leaflet** 

### What is the Freedom of Information Act?

The Freedom of Information (FOI) Act 2000 gives everyone the right to request information from public organisations including hospitals, health centres and health agencies. This means that you can access information about how the Health and Social Care Board (HSCB) works, how we spend public money, and how and why we make decisions.



You can also request information under -

- The Data Protection Act 1998 (DPA), which gives everyone access rights to their own personal information. The DPA covers both private and public organisations.
- The Environmental Information Regulations 2004 (EIR), which give everyone the right to environmental information held by public organisations.

## How can I get information about HSCB under the FOI Act?

There is HSCB information available on our website through our online Publication Scheme -

This information is provided free of charge and routinely updated.

All requests for copies of information under the FOI Act must be made in writing. It will be helpful if you tell us what information you are requesting, and give us your name, address and contact telephone number.

## Is there any cost for getting information?

Information will be provided free of charge up to a value of £450, however, if there are production costs, such as photocopy and laser printing, there will be a nominal charge. These production costs will apply to all requests.



# What information is available from the Board?

The FOI Act gives you the right to access almost all the information the HSCB holds, but there is some information, which cannot be made public. Information given in confidence, information relating to national security or law enforcement, and personal details about others cannot be provided, these are known as 'exemptions'. You can obtain your own personal information through the Data Protection Act.

# What happens if the information is not available?

The FOI Act does not require us to provide information that we do not already gather, however, we do have a duty to help you with your request. We will contact you and tell you what information we do hold and whether that may help with your query.
