Re: Freedom of Information Act 2000 Investigations into the deaths of patients with a learning disability

Thank you for your information request indicated in bold below, which has now been considered under the Freedom of Information Act 2000 by NHS South Cheshire Clinical Commissioning Group (CCG). I am able to provide you with the following information and responses.

# You asked:

Please would you provide the following information for your CCG:

1. The number of deaths of patients with a learning disability that occurred in the last three years (by years defined as 1/4/16 - 31/3/17, 1/4/17 - 31/3/18, 1/4/18 to present).

### Our response:

1. NHS South Cheshire CCG does not hold the total number of deaths of NHS South Cheshire CCG patients with a learning disability that occurred in the last three years. While NHS South Cheshire CCG partakes in the Learning Disabilities Mortality Review (LeDeR) programme delivered by the University of Bristol, this only applies to deaths which are reported to the central LeDeR programme team. The number of LeDeR reviews for NHS South Cheshire CCG will therefore not reflect the total number of deaths of patients with a learning disability. ### You asked:

2. The number of independent investigations into the deaths of patients with a learning disability that you have commissioned in the last three years (defined as above)

## Our response:

2. NHS South Cheshire CCG has not commissioned any independent investigations into deaths of patients with a learning disability.

As set out in Question 1, NHS South Cheshire CCG partakes in the Learning Disabilities Mortality Review (LeDeR) programme delivered by the University of Bristol. This is not however an independent investigation as it involves gathering information from the relevant health and social care professionals involved in that person's care.

Similarly NHS South Cheshire CCG quality assures Serious Incident reports completed by our providers into unexpected deaths of patients in receipt of NHS-funded care. However, these are also not independent investigations, as they are investigated by the relevant healthcare providers.

Our Designated Safeguarding Professionals also support reviews undertaken by the Local Safeguarding Children's Boards and Local Adult Safeguarding Boards but these are not independent investigations.

### You asked:

- 3a. The number of deaths of patients with a learning disability that have resulted in an inquest in the last three years (defined as above)
- 3b. Of those inquests the number that were an Article 2 inquest

## Our response:

3 a-b. NHS South Cheshire CCG does not hold information on the number of deaths of patients with a learning disability that have resulted in an Inquest nor how many of these were an Article 2 Inquest.
