Please would you provide the following information for your CCG:

- 1) the number of deaths of patients with a learning disability that occurred in the last three years (by years defined as:
- 1a) 1/4/16 31/3/17,
- 1b) 1/4/17 31/3/18,
- 1c) 1/4/18 to present).

NHS Harrogate and Rural District Clinical Commissioning Group (HaRD CCG) does not hold summary data related to this request. HaRD CCG is part of the national Learning Disability Mortality Review programme to review all reported deaths of people with a learning disability in England. It is the intention to provide an annual report on the work of the programme therefore under Section 22 of the Freedom of Information Act (Information Intended for Future Publication), HaRD CCG invokes its right to exempt from providing further information at the current time.
