### **Response**

The Council holds the information requested and the answers to your questions are below:

#### **1) How many employees are working in the council?**

As of 30th June 2018, the number of employees directly employed by the London Borough of Camden was 4,085.

Microsoft and Oracle are our main software vendors.

#### **11) Do you use Azure / Amazon Web Services or Office365?**

Yes we do.
