I'm referring to all communal works carried out on the financial year ending 2018: (heating and hot water, estate charges, building charges, estate lighting, building lighting, lift repairs, cleanliness charges, ground maintenance, communal door repairs).

I understand accounts for the final year won't he ready at this time and some of this repairs arent chargeable.

I would like to recieve a full list of all communal repair carried out regardless of the costs associated although if you have this information please include it too

Again I understand this would be drafted costing.

One more things was to include all Alphatrack works on the club room regarding fire safety equipment and testing for the same financial year.

Our Response:

Please find attached the communal repair records for Conant House and the Club Room.

We do not hold this information for cleaning and grounds maintenance as there is no specific amount allocated to Conant House, for these works there is a set budget for both of the services across the borough. The works are then carried out as and when necessary for each block and estate.

Personal data relating to junior officers and other third party individuals has been withheld pursuant to section 40 of the Freedom of Information Act. Section 40 is an absolute exemption and doesn't require consideration of the public interest test.

This letter acts as a refusal notice pursuant to section 17 of the Freedom of Information Act for the information which we are saying is exempt.
