



I was shocked to see that you felt it necessary to remove a poster with a simple message of appreciation for much loved writer and philanthropist, JK Rowling, from Edinburgh Waverley station.

JK Rowling has recently spoken about her belief that biology matters in women's lives. The vast majority of people who use your services and pass through this station share this fundamental belief in the importance of human biology. She has expressed support for transsexuals and transgender people. But because she does not share a very recently promoted belief that people can literally change their biological sex, she has received vile rape and death threats. By removing the poster you have - very politically - aligned your organisation with the people who send those threats.

Your actions have helped legitimise the belief that anyone who states that they don't believe human beings can change sex deserves to be abused. You have effectively encouraged further abuse of JK Rowling and spat in the face of her fans and people who share her very moderate views.



I understand your own organisation has taken public positions on many issues that the general public would regard as political. You celebrate "Pride" which consists of small limited companies and charities that hold political campaigning events and street parties promoting equality for LGBT issues. It is not necessary for your public sector duty of respecting minorities that you engage with Pride, but you chose to do so. 

I understand you are the Chief Executive of Network Rail. I also understand a billboard - stating "I heart JK Rowling" supporting a well regarded children's author has been removed from Edinburgh station at the behest of Network Rail Scotland.

Firstly, JK Rowling has the right to express her opinion on any topic. But she has had a number of false accusations thrown at her, most notably a false accusation of "transphobia". If you read her own words it is clear this is false, as she states clearly: "I respect every trans person's right to live any way that feels authentic and comfortable to them. Network Rail's current actions are causing adverse publicity.. As was recently written in the Spectator "Network Rail's double standards are lamentable and speak to a cowardly corporate culture"

A spokesperson for Network Rail recently told the Times "The poster in question is against our code of acceptance for advertising in our stations owing to its political nature." A moment's reflection can establish this is nonsense. Supporting a children's author does not have a "political nature".

I disagree with the implicit political position Network Rail are taking by choosing to censor a billboard supporting a woman with no political message.

I disagree that you should censor women.

I disagree with Network Rail taking a stance, and should simply allow apolitical adverts to be broadcast.

I look forward to hearing about how you will either:

- a) reinstate the poster and maintain a nonpolitical stance by refusing to be drawn one way or the other and simply get on with the job of delivering good rail infrastructure.
- b) or a recognition that Network Rail is allowing itself to be politicized by making a political choice to to censor support for women.

I write to complain about the removal of a poster showing support for JK Rowling at Edinburgh Waverley Station.

JK Rowling has recently made a huge stir by commenting on the 'gender debate'.

It is important to recognise that her writings have been entirely supportive of trans people, nuanced, thoughtful, and mindful of the violence and discrimination that both trans people and girls and women face in their lives, but critical of medicalising children who don't conform to rigid outdated stereotypes.

I understand a poster was displayed to show her support and celebrate her 50th birthday tomorrow.

This was removed after complaints by trans activists.

Firstly, no one has claimed the poster was transphobic, only that Ms Rowling herself is currently seen as being problematic owing to her recent writings.

You can surely promote and care for the wellbeing of LGBT workers and customers without showing support for an overtly political organisation, (when your own advertising code says you must not support any such organisation). All advertising has a political standpoint because any product has an impact on the environment so any form of promotion indicates that network rail supports the destruction of the environment so please be aware that all these adverts should now be banned.

This is a woman who has risen from poverty and domestic abuse and yet you fail to allow a poster that recognises her achievements on the whim of a small community. It is disappointing. Again quick reminder of what a "terrible" person she is below:

I refer to the removal of an advertising poster from your Edinburgh station due to it being against your code "owning to its political nature", which a spokesperson for network rail went on to state meant it was "likely to support or promote one viewpoint over another".

This is a surprisingly wide definition of "Political". Indeed, I would be surprised if any advertisements would fall outside it (after all, adverts for toilet paper, for example, generally express the view point that loo paper X is better than other loo papers Y and Z). Will they now also be cancelled?

But we both know this isn't really about any actual existing "code". This is about you crumbling against rabid bullying - scared you'll be the next to be "cancelled" by the screeching mob.

JK Rowling has been pilloried for making a simple statement that the vast majority of the public believe to be true: sex is a biological fact. You can't change your sex. Taking hormones and undergoing surgery might change some aspects of your appearance, but they do not change your biology.

Please reconsider your position on this. JK Rowling and other feminists have no problem with transgender people. They mean them no malice.
