We spoke. You agreed to provide technical advice to HS2 Ltd between now and the end of December on the PLD LDM model comparison project. For this project this is likely to take the form of reading project reports, attending project steering group meetings and providing further advice as requested to the contractors and/or HS2 Ltd. I attach the project specification and the proposals we accepted from URS Scott Wilson and Rand Europe.

The project inception meeting has been arranged for Wednesday second of November which we agreed you are unlikely to need attend. You agreed to attend the interim project meeting fixed for 11am, Monday, 28 November. A final project steering meeting will be arranged for December.

Payment for this work would be on a time and materials basis under the existing contract 0075 which we mutually agreed would run to the end of December 2012 (and should the government decide to proceed with HS2 Ltd). My expectation is that you would incur costs at a maximum rate of up to one day's preparation per steering group meeting, plus up to 1 further day for the steering group meeting itself and any follow-up. Significant cost in excess of this rate would be notified/agreed in advance.
