Thank you for your two Freedom of Information requests of 11th July. Please accept my apologies for the delay in replying.

You also made a number of similar requests dated 30th June and 11th July, which were responded to in a previous letter. Therefore, this response focuses on any further questions you've raised.

You asked about the need to sign a JSA Claimant Commitment rather than keep your existing Jobseeker's Agreement.

This was answered in our previous letter to you, so in summary, retaining a Jobseeker's Agreement when the details in it are to be amended is not possible.

The Jobseeker's Act 1995 requires JSA claimants and employment advisers to enter into a jobseeker's agreement. Historically, the details of this agreement were recorded on a document known as a Jobseeker's Agreement. Although the legal requirement to enter into such an agreement remains, a policy decision was made to move from a Jobseeker's Agreement to a JSA Claimant Commitment, as a means of recording claimant requirements. Therefore, JSA claimants need to agree and sign a JSA Claimant Commitment, which sets out the actions they need undertake to satisfy the entitlement conditions for JSA; to be actively seeking and available for employment. It is a legal requirement for claimants to have signed a JSA Claimant Commitment (which is a Jobseeker's Agreement for the purposes of the Jobseeker's Act, 1995).

You specified a list of postcode districts for when JSA claimants need to accept a Claimant Commitment.

The postcode districts specified in SI 2013/987 are not relevant to claimants making a claim for JSA under the 1995 Act. Those postcode districts are for claimants making a claim to new-style (contributions-based) JSA under the Welfare Reform Act, 2012. Therefore, the introduction of Universal Credit in a particular geographical area is not linked to the need for someone to have a JSA Claimant Commitment rather than a Jobseeker's Agreement.
