3. The total legal spend by the Council on the Harthill planning applications and associated litigation is £36,574. The Council has also been ordered to pay the Claimant's costs (subject to a cap of £35,000) and has made an interim payment of £30,000 towards these. The payment of the Claimant's fees has been set by Court as 70% of 85% of the Claimant's costs subject to a cap of £35,000.

This concludes our response.
