Your request is as follows:

I would be most grateful if you would provide me, under the Freedom of Information Act, details in respect to the contract below.

Kitchen Management System Hardware

The details we require are:

** Suppliers who applied for inclusion on each framework/contract and were successful & not successful at the PQQ & ITT stages* * Contract values of each framework/contract (& any sub lots), year to date * Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?*

** Who is the senior officer (outside of procurement) responsible for this contract?*

For clarity, the details of the successful and unsuccessful suppliers are kept in the strictest confidence. These details are used only to contact and support suppliers regarding their bidding activity for the relevant contracts.

I can confirm that Cheshire East Council holds the information you have requested. I have detailed below the information that is being released to you.

This was a call off procurement from the YPO Kitchen Management Framework 684. The contract was awarded back in 2017 as a 2 + 2 year contract (2 x 12 month extension options). Cheshire East Council have just taken the option to extend the contract for 1 year, there is still a further 1 year extension left to take.

The annual contract value is circa £85k.
