Dear Mr Mounokoliavitz

Reference: Freedom of Information Internal Review: FOI 19/181

Thank you for your e-mail dated 19th August 2019 in which you requested that I carry out an internal review of the University's decision to provide certain information to you in relation to your freedom of information request dated 19th July 2019 (under reference FOI 19-150).

The Decision:

The response from LIMU is dated 19 August 2019. I note that this response provided the following information:

- The total number of candidates who applied for a law-related course in UCAS Clearing 2018: "106. This is the number of students who were made an offer through clearing."
- ➤ The number of candidates whose applications through Clearing were accepted: "102. This is the number of students who accepted an offer made through clearing and enrolled."

Further information was requested through FOI 19-150, specifically the number of candidates who achieved specific grade combinations, e.g. AAA, AAB, ABB etc. There were ten such combinations in total.

The University withheld this information citing Section 43 of the FOIA:

"The University withholds this information under Section 43 of the FOIA as it is likely to be prejudicial to its ability to participate competitively in a commercial market."





Outcome of my review:

I have now conducted a review of the University's decision and it is my view that the decision not to disclose the full information on 19th August 2019 was compliant with the requirements of the FOIA. At that time, and due to the ongoing Confirmation and Clearing 2019 period, a likelihood of prejudice to our commercial interests did exist.

However, the Confirmation and Clearing 2019 period has concluded, and it is now my view that the likelihood of prejudice to our commercial interests has reduced, and the arguments for the exemption can no longer be sustained.

Therefore, please find the information you requested at **Annex 1** below.
