**Freedom of Information Request**

**Response from West Leicestershire Clinical Commissioning Group**

Thank you for your request which was received by West Leicestershire Clinical Commissioning Group (WLCCG) on Wednesday 19<sup>th</sup> August 2020, for information under the Freedom of Information Act 2000.

Please find below your questions for ease of reference (in italics) and the organisation's response.

Please note that the LeDeR programme covers Leicester, Leicestershire and Rutland (LLR) therefore all information provided below is LLR data and not specific to West Leicestershire CCG only. For your reference, there are three CCGs in LLR; West Leicestershire CCG, Leicester City CCG and East Leicestershire and Rutland CCG.

**Question 1:** *Who is the LeDeR Local Area Contact (LAC) for the CCG?*

**Response to Q1:** Wendy Pinson (Senior Nurse) at the CCG and James Lewis (Lead Commissioner - Working Age Adults) at Leicestershire County Council.

**Question 2:** *How many Local Reviewers are engaged by the CCG? Of these, how many are permanent employees?*

**Response to Q2:** As of 1st September 2020, there are 29 reviewers of which 20 are permanent employees.

**Question 3:** *How many LeDeR notifications did the CCG receive in 2018?*

**Response to Q3:** 55.

**Question 4:** *How many LeDeR notifications did the CCG receive in 2019?*

**Response to Q4:** 59.

**Question 5:** *How much did the CCG spend on agency or independent LeDeR reviewers in the last financial year (1/4/19 to 31/3/20)?*



**Response to Q5:** £7,200.

**Question 6:** *How are reviewers paid (e.g. hourly, daily, or per review completed) and what is the average/standard rate of pay?*

**Response to Q6:** £400 per review.
