We apply Section 40(2) of the Freedom of Information Act 2000, 'Personal information', to Questions 1-5. This acts as an exemption notice.

As the information requested is personal information, it is exempt under Section 40(2) by virtue of Section 40(3A)(a) of the Freedom of Information Act 2000 (as amended). Disclosure under the Freedom of Information Act is deemed to be to the public at large. This information cannot be disclosed because its disclosure to a member of the public would contravene one or more of the data protection principles relating to the processing of personal information. They are set out in Article 5(1) of the General Data Protection Regulation and section 34(1) of the Data Protection Act 2018.

As a public authority, Surrey County Council must observe all of the data protection principles when processing personal data. The exemption from the duty to disclose personal data where to do so

would breach a data protection principle is an absolute exemption; the public interest test in section 2 of the Freedom of Information Act does not apply.

A public authority is obliged only to disclose the names of colleagues whose job roles are classified within certain levels of its organisational structure. The details of colleagues whose roles do not sit within that bracket are withheld under the terms of the Freedom of Information Act 2000.
