Freedom of Information Act 2000 request: Legal Costs

With reference to your request for information, dated 13 October, made under section 1(1) of the Freedom of Information Act ('the Act'), I am writing to inform you that the information you require does exist and is held by Central London Community Healthcare NHS Trust (CLCH). The information you require is listed below, subject to exemptions.

You asked the following:

"I understand that you are currently appealing the proposed civil monetary penalty imposed by the ICO. I note you have instructed your lawyers and therefore I'd like to request the name of any external lawyers you have engaged in this matter. I would also like to request any costs that have so far been incurred and any recorded information about how much has been budgeted for legal costs."

The Trust has sought legal advice and representation from Field Fisher Waterhouse LLP with respect to the proposed civil monetary penalty imposed on it by the Information Commissioner's Office.

Details of the legal costs payable to Field Fisher Waterhouse LLP are held, however the Trust considers that this information is exempt by virtue of Section 43 - Commercial interests. More specifically the Trust considers that section 43(2) is applicable in this instance.

The legal costs in question are capped at a fixed rate. Section 43(2) states that "Information is exempt information if its disclosure under the Act would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it)".

We believe that revealing details of what the Trust is paying its legal advisers in this case would be detrimental to their business interests and the relationship between the Trust and them. If this information were released into the public sector, other legal firms could benefit from the pricing details of services that Field Fisher Waterhouse LLP provides.

Section 43 is a qualified exemption and as such the Trust is required to apply the public interest test, set out in Section 2(2)(b) of the Act.
