Request for an internal review

I have now undertaken an internal review of your Freedom of Information Act request dated 4 February 2010 and Alex Bostock's response to you dated 4 March 2010.

Taking into account ICO guidance and the section 45 Code I have undertaken a thorough reconsideration of your request, how it was handled and the decision taken and determination of the public interest test.

I have taken into account everything you have set out, a previous decision from the ICO, legal advice and all other relevant factors and information.

My decision is that the University decision that exemptions under sections 43(2) and section 42(1) of the Freedom of Information Act are engaged and its determination on the public interest test under both sections are correct based on the reasons given in Alex Bostock's letter dated 4 March 2010.

The University requests that information includes the name of an individual responsible for the purchase of goods and services within the University is only re-used by you (or any third party to whom you may pass this information) if permitted to do so under the terms and conditions of the Data Protection Act 1998 (which gives individuals the right to prevent processing for direct marketing purposes) and Privacy and Electronic Communications Regulations 2003 which require that individuals knowingly consent before they are contacted for direct marketing purposes by electronic means such as telephone, fax, email, text message and picture (including video) message and by any automated calling system.
