



Types of URI:

1. Identifier URIs (Works)
2. Document URIs (Expressions)
3. Representation URIs (Manifestations)

Identifier URIs

Identifier URIs follow the template:

`http://www.legislation.gov.uk/id/{type}/{year}/{number}
[{section}]`

Example: The identifier URI for the second Act of the Scottish Parliament made in 2014.


Document URIs

Document URIs follow the template:

`http://www.legislation.gov.uk/{type}/{year}/{number}
[/{section}] [/{authority}] [/{extent}] [/{version}]`






Example: The version of section 16 of the Wildlife and Countryside Act 1981 (c. 69) that applies to Scotland.
