FREEDOM OF INFORMATION REQUEST REFERENCE NO: 1065.2021-22

I write in connection with your request for information which was received by North Yorkshire Police on 21 February 2022. Please accept our apologies for the delay in this response. I note you seek access to the following information:

For the calendar years 2019, 2020 and 2021 – could you please respond with:

- 1. The number of reported crimes which mentioned “road rage” in the MO field of the crime report and the detailed crime type.*
- 2. The number of road traffic accidents recorded with a contributing factor of “aggressive driving” (code 601)*

Extent and Result of Searches to Locate Information

To locate the information relevant to your request searches were conducted within North Yorkshire Police. I can confirm that the information you have requested is held by North Yorkshire Police.

COMPLAINT RIGHTS

Are you unhappy with how your request has been handled or do you think the decision is incorrect?

You have the right to request that North Yorkshire Police review their decision.

Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again –

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter.

That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision North Yorkshire Police made under the Freedom of Information Act 2000 (the Act) regarding access to information you can lodge a complaint with North Yorkshire Police to have the decision reviewed. North Yorkshire Police must be notified of your intention to complain within 2 months of the date of its response to your Freedom of Information request. The Information Commissioner
