Dear Ms Ferstman,

Thank you for your email dated 21st August 2018 requesting the following information:

"Could you share with me the list and status of cases currently under DSP review? In particular, the status of IHAT 87 (Saeed Shabram / Saeed Radhi Shabram Wawi Al-Bazooni); and IHAT 153 (Baha Mousa)?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

For the purposes of this response to your request concerning cases currently under DSP review as at 21 Aug 18, and in the context of the request for information, where you have referred to cases "under DSP review" we have deemed this to mean "IHAT" cases that have been referred to the SPA for review under section 116(2) of the Armed Forces Act 2006, or where charges have been brought by the SPA and the case has not yet been concluded.

A search for the information has now been completed within the Service Prosecuting Authority, and I can confirm that as at the date of your request, no cases were under DSP/SPA review.

Concerning your request as to the status of IHAT 87, this case has previously been subject of a referral to the SPA, and a decision was made not to prosecute. It is currently with the Iraq Fatality Investigations enquiry under Sir George Newman. Information can be found on it's website at: https://www.gov.uk/government/collections/iraq-fatality-investigations. The request for information as to its status as at 21 Aug 18 is therefore exempted under section 21 FOIA (Information Reasonably Accessible to the Applicant).
