## Freedom of Information request - RFI 1231

Thank you for your request for a list of joint committees as defined under section 102 of the Local Government Act (LGA) 1972.

The Commission holds some of the information you request, but not all. Section 102 of the LGA 1972 defines joint committees as made up of 'two or more local authorities'.
