Release of Information

“Please provide, in list format, including dates and titles, all film and television production teams that have worked with or received support (financial, advisory, or material) from the Royal Navy from 2013 to 2014.”

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000 (The Act).

A search has now been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held. The available information in relation to the television and film production teams that have received support from the Royal Navy during the time period stated in your request can be found in the table at Annex A to this letter.

Please be advised that no recorded information is held by the Department in respect of support given to News Outlets or Live Television during the time period stated in your request.
