The passage and stoppage of all vehicles is prohibited in the following roads on the stated times on Saturday 30th October 2010 for Bonfire Celebrations:

- 1. Duke Street (junction of Franciscan Way to the junction of Avon Road) and eastern end of Anchor Springs from 7.30 p.m. to 8.45 p.m.
- 2. Maltravers Road 4.00 p.m. to 11.00 p.m.
- 3. Fitzalan Road (South from East Street junction) 4.30 p.m. 11.00 p.m.
- 4. Maltravers Drive 4.30 p.m. to 11.00 p.m.
- 5. Granville Road, Selbourne Road, St. Winefrides Road, Church Street, Manor Parade, East Street, Beach Road, St.Catherine's Road, South Terrace, Irvine Road (junction with St. Catherines's Road to the junction with Fitzalan Road 6.30 p.m. to 10.30 p.m.
- 6. Sea Road (from Junction of South Terrace/Norfolk Road to Swimming Centre 6.00 p.m. to 10.30 p.m.
- 7. New Road, Surrey Street (to junction with High Street precinct), Beach Road (from East Street junction to the War Memorial) from 4.45 p.m. to 5.45 p.m.
- 8. East Street from Gratwick Arms corner to Barclays Bank corner from 4.00 p.m. to 10.00 p.m. (for the erection of crowd barriers).
- 9. St Flora's Road (from Junction with Parkside Avenue to Sportsman Roundabout) 6 p.m.- 9.15 p.m.

- 10. Berry Lane (junction with St Flora's Road to junction with Southway) 6.00 p.m. 9.15 p.m.
- 11. Beach Road (South of junction with Maltravers Road) 3.00 p.m. to 11.00 p.m.
