Thank you for your recent request. Your request was actioned under the Freedom of Information Act 2000 in which you requested the following information –

- '[1] Please state how many non-executive directors there are
- [2] Please name all the non-executive directors [as all other positions have been named, I expect an answer to this question]

LCCs contributions [as Primary Funder] to Liverpool Foundation Homes is £2,637,690. An FOI response from LCC states that the total salary bill for the first year will come out of the £750,000 equity investment fund.

- [3] What was the total salary bill for all staff executive / non-executive etc in year 1
- [4] What was the total salary bill for all staff executive / non-executive etc in year 2?
- [5] Where did the money come from to fund the salaries in the second year?

As LCC has contributed £2,637,690 of taxpayers money in loans to Liverpool Foundation Homes Ltd please explain:

- [6] why this company is still classed as Dormant [no accounts] since its incorporation in March 2018?
- [7] When / how are these loans to be paid off by Liverpool Foundation Homes

Response

Liverpool City Council would firstly take the opportunity to apologise for the delay in responding on this occasion. By way of context and as you may be aware, Liverpool City Council in common with all other public authorities in the UK, Europe and worldwide have, since March, been dealing with and responding to the Coronavirus pandemic. The introduction of substantial Government restrictions well before the submission of your request have had wide reaching and ongoing impacts being felt across society. These impacts specifically affected all Service Areas of the City Council as Officer resources and personnel are diverted to supporting the most vulnerable residents of this city.

Specifically, from early March, direct impacts were being seen for the City Council in terms of staff absence due to symptoms of or self-isolation due to Coronavirus as well as significant and substantial increases in demand for those Services which specifically support children, the elderly and the most vulnerable residents across Liverpool.

In light of the above factors, Officers from early March were gradually and in increasing numbers assigned to different Service Areas to ensure continuity of service, provision and support for children, the elderly and the most vulnerable residents across Liverpool as indicated above.

This impacted considerably on the ability of colleagues to identify, retrieve and collate information, as well as the absence of relevant Officers whose knowledge informs the preparation and content of responses whilst resources are focussed on the ongoing pandemic.

- 6. The accounting period is November 2018 to March 2020. Accounts will therefore be filed by March 2021. On this basis as this information is intended for future publication and in accordance with the application of Section 22 of the Freedom of Information Act 2000 we would refer you to the comprehensive search facilities available via Companies House https://www.gov.uk/get-information-about-accompany
- 7. The loan facility at present relates to Park Street. Required information relating to loan transactions will be available in the published accounts as detailed in our responses above.
