Our response to all the above questions is within the attached document entitled FOI\_17-309 Appendix A. Please note that for consistency we have included applicants with a prediction of BBB within our response to question 1.

It should be noted that the data presented in questions 1 and 2 only represents a portion of the applications received by, and enrolments with UEA for the M100 Law programme.

The table below illustrates that there were a large percentage of applicants and enrolments outside the requested range of predicted and achieved grades.

Year	%age of applicants with predicted grades of A*A*A* to BBB	%age of enrolments with achieved grades of A*A*A* to BBB
2014	52%	35%
2015	47%	51%
2016	50%	56%
2017	40%	46%

In regards question 3, we would add that the typical offer for the 2014 to 2016 entry class was at the AAB level and for the 2017 entry class it was at the AAA level.
