





Dear Sir,

I have just returned home from visiting Lumiere in Durham City tonight, which whilst being an extremely enjoyable and fun experience which clearly tens of thousands of people enjoyed, the event was marred by serious concerns about public safety which may be worse over the next 2 or 3 days if crowds increase.

We had a great evening until we reached the market place around 19:10 and were being held back by a crowd control measure in place to prevent further people progressing towards the cathedral. Understandably there was a concern in the number of people on the peninsula and a decision was made to prevent further people causing a public safety issue. Barriers were placed across the entrance to the market place next to Natwest Bank and stewards tried to explain that no one was allowed to progress any further. There were no loudspeaker units used to explain the problem to the crowd that began to gather and push against those ahead of them. No path was created to allow people out of the peninsula, and thus the crowd began to develop beyond Tesco and more and more people began to push. I became concerned for the safety of my mother as the crowd and pushing got worse, I managed to get her to the side and speak to a female steward and explained that if they did not ease the congestion from the market place leading down to ards Marks and Spencer people were going to get hurt, she explained that the peninsula was crowded and they needed to stop people going up there. I explained that if they were not careful a crush incident was going to happen near Tesco at the Market Place, and the conditions there were unsafe. She said "Well, what am I supposed to do" and walked away from me. Then when I went to speak to a police officer she tried to prevent me speaking to them. I explained to the police my concerns, initially the two officers were dismissive stating that the matter was one for the private stewards. Until I explained that if this became a major incident and that seemed likely in my opinion that police would have primacy and become lead agency - perhaps they should speak to their silver commander, they agreed to ask for some PCSOs. There still was no route for those leaving the peninsula and the crowding continued to increase significant with crushing and jostling.

To give my thoughts some context, I am a former and and I have never been so concerned about public safety from potential crush issues as this situation was.

As Thursday was deemed to be likely to be the quietest night (according to the media) I am very concerned that this situation could be significantly worse over the weekend and I ask you to reassess your plans and contingencies for the event.

I am particularly concerned at the lack of interest, abrasiveness and lack of awareness of the steward and hope someone can direct me as to how I can raise concerns about this.

I can do no further than raise these concerns with you, lets hope there is not a major incident in Durham this weekend.

My feedback from tonight:

Generally busier than last year (I was there Thursday and Sunday last year)

Sadler Street needs many more stewards in the area from Hide to Palace Green. Ideally they need to have loud speakers to communicate with the crowd.

The one way system we agreed at the bottleneck leading up to palace green wasn't in place when I visited this area although I understand that it was later. More stewards in this area are required who need to be proactive with the crowd.

There needs to be more announcements at palace green re the exiting arrangements from this area and stating when the next display will start.

The roadshow outside of the HMV was good although this partly blocked access/egress around this area. Think this needs to be stopped/moved for the weekend.

There was a problem re road closures. The Police need to robustly enforce these as Simon witnessed a car driving down from palace green through masses of people walking in this area just before the parade reached this area.

The parade was delayed for ten minutes due to the claypath road closure not being enforced.

Seemed to be generally less stewards than last time despite there being more people.

Belmont Park and Ride was full. We need some traffic management in this area over the weekend and probably at the other park and rides.

I didn't see any problems re concessions.

My biggest concern is the access and egress arrangements to Palace Green. This needs to be resolved before Friday night. Monitoring is required throughout the weekend to make sure what was agreed happens.

Issues Arising from Lumiere 17 November 2011

Silver Meeting Artichoke/Police/DCC 2pm Radisson Hotel

- Special events on Thursday caused some of the initial problems (e.g. parade) and will not be happening during the remainder of the event.
- Artichoke had 200 staff (stewards and volunteers) on duty yesterday
- Artichoke aims to deploy additional 15 20 stewards to the key points. All stewards will wear high visibility jackets, loud hailers will be available and stewards are instructed to be more proactive.
- There was an issue of people failing to adhere to directions given to them, albeit that probably relates to an absence of proper briefing to stewards to give the appropriate directions
- Artichoke admitted only part of their steward plan was implemented. There will
 be a stewards and Artichoke personnel briefing tonight, as the failure to do so
 last night compounded issues. Police will be briefed to act in support of the
 stewards to enforce their directions. N.B. Feedback from CCU staff present at
 tonight's briefing was that it was very positive and addressed the key issues
- Police & DCC made a series of recommendations, all of which were accepted by Artichoke
- Police are prepared to intervene if public safety issues arise
- Police will not provide any additional officers but will redeploy officers to identified choke points to support stewards
- Such areas include Prebends Bridge, Framwellgate Bridge and the Market Place
- Particular attention was paid to Owengate and Palace Green and a number of measures where agreed to alleviate problems e.g. additional police deployed and greater access to the Cathedral created.

- Issue at HMV Prince Bishops to be addressed with the Mall authorities
- Market Place measures to be taken to restrict entry of vehicles from 4pm, although can not be enforced until 5pm re the traffic order.
- Arrangements in hand to deal with the Choir school exit between 4 4.30pm
- North Road traffic issues DCC highways, Police and Artichoke traffic personnel have agreed measures to alleviate concerns in this area.
- Illegal Street traders Discussed with Joanne W and, subsequently with the police
- It was agreed that Artichoke PR would advise public to all attempt to get in during the first 2 hours

Conclusion

Artichoke recognised the need to improve their performance and accepted police/DCC recommendations to them. Police are prepared to be more proactive. If applied properly, the Event should be much better managed tonight.

- 2. Controlling the crowds waiting to get into the cathedral, the stewards weren't doing much and there was a little bit of bedlam as people tried to get in after the light show finished, nearly saw a punch up!!
- 3. Controlling the flows on the river bank routes from Prebands bridge to Framwelgate Bridge, they were sending too many down one side resulting in 45 min queues on one side and nothing on the other

I have mentioned these to Yvonne who will keep an eye on these.

Anything else you see when you're out and about I suggest you let them know

Have a great evening, I particularly recommend no 20 in South Bailey.



Lumiere 2011 – review

Durham

There were many marvellous things to see in Durham on Thursday night: a bridge that had miraculously turned into a waterfall; a cathedral that danced all about with flames; a souvenir snowdome so vast it had unaccountably swallowed one of the city's most famous statues. But my favourite sight had a human form. In the cathedral cloisters, where a vast sphere of fire turned mesmerisingly in the breeze, I caught sight of a nun. Yes, a nun. She was hopping from foot to foot with excitement, and grinning broadly, her pale, gentle face lit by both the spectacle and – here was the surprise – by the bright blue glow stick she was waving. I wondered about this glow stick. Had she bought it from a market stall? Or had mother superior handed them out at matins? I was about to ask, only then the crowd swallowed her up, and she disappeared into the night.

Ah, yes. The crowd. It rather got in the way on the opening night of Lumiere, Durham's

second festival of light (the first was held in 2009, and attracted some 75,000 visitors). At times, the city's narrow, winding streets were so full you simply couldn't move. Not that you could feel too cross about this. I cannot remember the last time I was in a British city so full of cheerful, excited people, and of every generation. Artichoke, the creative charity behind Lumiere (they are the people who brought London a mechanical elephant, and Liverpool a mechanical spider), believe that art is for everyone, and so they take it out of the gallery and on to the streets – and in Durham you could tell by looking at people's faces, and ear-wigging their conversations, how successful this strategy is. The throng was charmed and amazed, and it kept saying so, sometimes in reverent whispers, and sometimes with a joyful shout.

Lumiere 2011 is more than twice the size of the first festival: the work of some 30 British and international artists is on display in locations around the city, lit up between 6pm and 11pm (the organisers have persuaded their partner, Durham county council, to turn off many of the city's street lights, the better that we might enjoy it). I started in the market place, where the French artist Jacques Rival has built his installation, *I Love Durham*. The crowd around this piece was 10 deep, and it was easy to see why. Over Raffaello Monti's 1858 statue of Charles Vane, the 3rd Marquess of Londonderry, a local landowner, Rival has placed a transparent dome, thus turning poor Vane – a distinguished soldier, but also a loutish drunk – into a kitschy joke. On his plinth is written the legend "I Love Durham" in pink neon. Meanwhile, he is beset by blizzards of fake snow. Shoppers and workers walk by this statue every day without giving it a second glance. Now, though, they were agog, seeing it as if for the first time.

From here I walked up to the cathedral. Heart-stopping. Ross Ashton's *Crown of Light* had turned the building's north face into a huge canvas, covered with images of the Lindisfarne Gospels. Inside, Compagnie Carabosse, a group of French "fire alchemists", have filled the building with lanterns, each one made from a miner's vest. This was incredibly beautiful – the glowing torsos peaceful rather than sinister – though the soundtrack, performed by a man with a guitar by the altar, was a bit too Enya for my taste: silence would have been better. The best bit, though, was outside, in the cloister and the grounds, where a garden of fire – they call this work *Spirit* – licked and spat excitingly. I was so delighted by this – there were spirals of fire, and plumes of fire, and strange spherical braziers like red planets – that I didn't, at first, stop to consider the fact that we were allowed to wander among these things entirely freely (were the health and safety people too busy at St Paul's?). It was amazing: like some strange medieval pageant. (And since you ask, when Artichoke told the chapter clerk that their plans for the cathedral involved fire, his response was a cool: "Well, it's made of stone...")

After this, my two must-sees out of the way, I wandered willy nilly. You will perhaps not be surprised to hear that Tracey Emin's neon *Be Faithful to Your Dreams* leaves me cold, even if it is in an abandoned Durham graveyard rather than some noisy Shoreditch restaurant – and Deadgood Studio's *Rainbow* on Prebends bridge was a huge disappointment, being merely a series of coloured lights. But these are small gripes. Mostly, I was in heaven. Peter Lewis's *Splash*, in which Ove Arup's 1963 Kingsgate footbridge has been turned into a vast waterfall (it's best seen from Elvet bridge, a little distance away), is a piece of exceedingly clever engineering that transports you in an instant from County Durham to Victoria Falls. And I loved Cédric Le Borgne's *Les Voyageurs*, a series of spectral human forms that hunker mysteriously on roofs and walls in South Bailey, an ancient street so inkily dark you would be spooked were it not for the crowds. At South Bailey's every twist and turn another one would come into view, a staging that made you feel these exquisite sculptures were not static but moving; to me, it was as if they were gathering, though whether for benign or malevolent reasons I could not tell.

Finally, on my way back to my hotel, I took in *Lightwriting*, a collaboration between the designer Richard Wolfstrome and the writer Ira Lightman. This piece is in Millennium Place, a cultural "square" – theatre, library, plus requisite coffee shops and chain restaurants – so bland, so utterly characterless, it makes me want to kill myself. But reading the brightly lit, haiku-like stories Lightman has gathered from people who live in County Durham, you stop worrying about this. They are as authentic as Millennium Place is ersatz. "Witton Le Wear," said the last one I read before I headed for bed. "A pheasant flies into a dint's car." I puzzled that one all the way home.



Re: Saturday Nights Showing.



I am writing to make a complaint and ask for an investigation into the recent shambles that was called the Lumiere festival, with its poor crowd control and dangerous one way system.

l am a mobility problems which mean I cannot walk too far as well as balance and coordination problems. I attended the event with my partner and planned the route we were to take well in advance.

Some of the installations were obviously out of my limits and not safe for me to attend as they would mean long or dangerous walks, therefore we only planned to visit the ones in the market, Framwellgate Bridge, north road and the cathedral.

However when we did finally arrive, on the park and ride bus, which was poorly planned, after spending nearly an hour driving around three different park and ride sites trying to find a spot, we eventually found one at the Belmont site, and joined the queue for the bus, to get onto inadequately sized buses.

We managed to cope with this, and felt that seeing the Lumiere lights would make up for the wait we had.

However our first point of call was the market place to see the snow dome, which was a crush of people attempting to visit the cathedral and being held back and shouted at by rude stewards with mega phones.

Don't get me wrong the snow globe was amazing, but the crowd prevented any real enjoyment of seeing this. We decided that seen as we could not get close enough to the installation to get any good photos we would head up to our next point of call, The Cathedral.

The throngs of people attempting to get past the barricade were horrendous, and when the barricade was opened there was a mad rush to try and get through. In this throng I become separate from my party, and very anxious, and therefore attempted to get to a pre arranged meet point, at the gates to the castle, to meet my partner, as we had already discussed what to do if separated. However despite trying to talk to a steward and explain that I

we got split up, to meet here, I was not allowed past this point, and was only rescued when a bus driver friend saw me, and kept hold of me, while we attempted to locate my partner.

We did eventually find him, and were reunited, and decided that despite not getting into the cathedral, we would turn around as the crowd and the attitude of stewards was becoming very frightening for me. However at this point Stewards began to herd us down a back alley and onto the poorly lit river banks, we tried to stop and explain to a steward that we did not want to go this way, and that due to my disability we didn't think it safe to be on the riverbank, and wanted to return via the market place. However we were spoken to abruptly and told it was a one way system and that there was no choice, we had to go. This path became absolutely horrendous, and on a number of occasions I stumbled and fell and had to be hauled to my feet by members of the public and my partner who was struggling to hear what I was saying, as and urged on, to prevent a crush. There were no barriers along the river, and people were struggling to stay on the path, all the time being pushed here there and everywhere. I had reached my limits walking by then and was extremely frightened and scared, and in pain with my legs. Pictures of the Hillsborough disaster where springing to mind, and I had to fight my last strength to make it, any idea of visiting the installations were pushed to the back of my mind and all I wanted was a place of safety where I could stop, breathe and sit down. But I was denied that.


We were only too glad to get out of Durham this night, and were dreading news reports, fearing a duplicate of the Hillsborough disaster, I spent the night sitting up until 4am, worrying about family and friends who were still there while attempting to recover from my ordeal. I am absolutely amazed that nobody was killed or seriously injured in this poorly managed event.

Under no circumstances should disabled people be forced to go via a route not adapted to suit them that is not safe and poorly lit and I don't know where your stewards were hired from, but personally I found them ill advised, unplanned and aggressive. Surely people in such jobs should be trained to deal with disabled people, and acknowledge what is safe and is not. Instead of herding them like cattle to their death.

I will not rest until an official investigation is made into why and how this event passed a Health and Safety check, and I have had an official apology for being so blatantly discriminated against and put in a life threatening position.

This event was not only a breach of Health and Safety regulations; it also breached the Disability and the Equality Act 2010, and put many people at risk. This event should never be allowed to happen again, and those responsible for the mistakes made, should be disciplined and face demotion of some kind.

Please investigate this fully and let me know what the outcome is.
