What are the remaining DWP offices is mail not routed to the 2 MOUs

The full list of offices serviced by the two Mail Opening Units (MOU's) is available on the Gov.uk website at

Sites routed through Kidderminster are indicated by the line 'Mail Handling Site A' within their address and a postcode starting WV98, whilst sites that use Telford have 'Post Handling Site B' and a postcode starting WV99.

Both of our MOU's process mail on behalf of PIP and ESA sites.

There are no fax numbers available for Kidderminster and Telford. Our MOU's are solely for the processing of incoming mail and all other communications with DWP should be via existing routes.

The MOU's now serve all sites that have incoming customer mail with the exception of two remote Scottish Jobcentres (Kirkwall and Lerwick) and three part-time Jobcentres (Bordon, Alton and Hunstanton).
