I am writing in response to your recent request that we received on 05 March 2018 in which you requested the following information under the Freedom of Information Act 2000.

Please can you assist in providing the following information ?

1. Does the Group currently have a managed print contract ?
2. What are the start and end dates for this contract ?
3. Who is the current supplier(s) of this contract ?
4. Which procurement route or framework was used to procure this service ?
5. What is the approximate number of single function printers within the Group ?
6. Who are the main printer supplier(s) ?
7. Who are the main supplier(s) of print consumables (Toner, spares, etc.) ?
8. Does the Group have a support contract(s) for Printers ?
9. What are the start and end dates for the printer support contract(s) ?
10. What is the approximate number of MFD's or Photocopiers within the Group ?
11. Who are the main MFD / Copier Suppliers(s) ?
12. What are the start and end dates on the MFD contracts(s) ?
13. Is a tender planned for any of the above print services ? If so can you confirm the framework and potential release date ?

I can confirm that NHS Vale of York Clinical Commissioning Group (the CCG) does not hold the information you have requested.
