DM welcomed ND and RC to the meeting. ND is joining to help facilitate a session Welcome: around MCS values and RC is the Partnership Manager from the Studio Schools Trust to MCS.

Matters Arising:

Building Update

ML & RM updated the board on the building search. With the Education Funding Agency (EFA) a number of buildings have been viewed and they are now pursuing Gulam House on Blossom Street in Ancoats. It is available on a 999 year lease with an asking price around £1m plus land at the side which they would also try to procure.

It is a good size space (c2500sqm) which is flexible and could potentially host businesses as well. In a good location, just out of the city centre ward but close to where TechHub will be developing their 'Google Campus' and in an urban neighbourhood. The EFA have visited the building with their technical advisers and anticipate that an offer on the property will go in soon.

Grant Update

RM updated the board on the grant letter which has been signed and approved. The first payment of £90,000 from the £300,000 grant should come through soon. A budget breakdown proposing how the grant will be spent will be provided at the next board meeting.

Specialist Advisers Update

18 people/organisations have applied to be specialist advisers, including a good number of people not already know to MCS and who have useful and relevant skillsets. RM is waiting for LF to come back from holiday before arranging interviews with applicants to decide who will be recruited to support the pre-opening process.

Values Workshop: ND facilitated a workshop on MCS values. A separate document is attached with further detail on this.

Working Groups: ML introduced the board to the working groups the project team are suggesting should be established to support the opening of MCS. RM asked the board to submit information to a Google document to show which groups they feel they could contribute to and why. At the next board meeting these working groups will be discussed in more detail.
