I am unable to provide you with the requested information as details on individual salary and pension, including any documentation and internal correspondence thereof, are the personal data of a third party and disclosing it would contravene the data protection principles in Schedule 1 of the Data Protection Act 1990. NHS Orkney has applied an exemption under section 38(1)(b) – Personal Information of a Third Party of the Freedom of Information (Scotland) Act 2002

Details on the remuneration of board members for the last financial year will be included in NHS Orkney's annual accounts 2017/18, which will be published after they have been laid before the Scottish Parliament. They should be published on our website in October. An exemption is therefore applied under section 27(1) of FOISA – Intended for Future Publication.
