Apologies for the very short notice, but we'd like to have at least a brief run-through of the recommendations and discuss terms of reference before the next meeting of the Strategy Board on the 3rd April.

These are the recommendations we have been asked to cover. We need to get some idea as to what each recommendation means, and to discuss what it is desirable / realistic to deliver in each case, along with potential timescales. Most of my thoughts currently focus on Rec 2 (i.e. what government/police CCTV standards could be developed, both for image quality and data export), but this needs to be scoped out in more detail, as do the recommendations.

The next meeting of the National CCTV Strategy Standards subgroup will be held on 10th September, 10:30-12:30 at the NPIA, New King's Beam House, 22 Upper Ground, London, SE1 9QY, room 8/9.

The main focus of this meeting is to discuss progress on Recommendation 2 "Agree on digital CCTV standards and digital video formats for public space CCTV, police, and CJS use".

In particular we will be reporting on plans to develop some specimen Operational Requirements for a range of key environments (e.g. licensed premises, shopping centres, stations etc.) to include standard camera placements and image quality criteria – to provide more assistance to people when developing their own operational requirements and to try and raise front-end standards of the installations.

We will also be looking at minimum equipment standards for the digital video recorders, specifically recording/export data formats to improve interoperability and ease of replay.
