This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is some public interest in release because there is public interest in the work carried out by Scottish Government Ministers. However, there is a greater public interest in the use of public resources. Since providing this information would create a duplication in work, we have determined this would not being a responsible use of public resources and therefore not in the public interest.

Your right to request a review
